This is the first meeting of the 2019-2020 school year, therefore, there are no minutes available.

Budget Requests

Ms. Klaczynski is requesting funds for band & choir activities – the requests are covering the entire school year. Ms. Rodriguez praised Ms. Klaczynski for all the hard work she does for the music program. The School Site Council agreed that the funding for this program is a good idea. Ms. Leber wanted the council to keep in mind that the district has stated that some school funds will possibly be cut this year.

Items #1 - #10: Ms. Klaczynski is requesting funds for festival fees and transportation for various choir & band performances for the total cost of \$8,480.00 – Mr. Larson made a Motion to approve, Ms. Mendoza seconded. Motion passed.

Ms. Leber presented the 2019-2020 School Safety Plan. She advised the council that this document is a living document and can change periodically upon approval from the School Site Council. This document spells out safety and emergency procedures and strategies in order to keep our staff and students safe. The document also includes board policies in regards to site discipline.

Ms. Leber presented the 2019-2020 School Plan for Student Achievement. This document is also a living document, which can change periodically upon approval from the School Site Council. This plan lists budgets and allocations of our school funding. Hillview is a Title 1 school and has specific rules in regards to expenditures. All Title 1 expenditures must be outlined in the School Plan. LCFF funding, is also included in the School Plan. The State just released new information on CAASPP, and will be added to the plan. Ms. Rodriguez asked about Title 1, wondering how these particular funds are spent. Ms. Leber explained that Title 1 funds are used for student support, professional development, staff trainings, etc. Mr. Davis made a motion to approve the School Safety Plan and the School Plan for Student Achievement as living documents, Mr. Larson seconded. Motion passed.

Ms. Rodriguez has volunteered to serve on the District Advisory Council. The DAC meets once a month – this council is comparable to the Site Council but at the district level. After Ms. Rodriguez attends the DAC meeting, she will report back to the School Site Council.

Ms. Garcia asked if other teachers, specifically Science and Math teachers, can request the use of Title 1 funds. Mr. Larson stated, and the council agreed, that all teachers are entitled to request funds from the School Site Council.

Ms. Garcia would like to see some type of running program started at Hillview for all students. Mr. Davis is also willing to be a part of this program.

The next scheduled meeting will take place on November 14, 2019.

Mr. Larson made a motion to adjourn, Ms. Mendoza seconded. Motion passed. The meeting was adjourned at 12:10 pm.
